FOREWORD

The following general information on the 1998 entering class has been prepared to supplement admission materials assembled prior to the matriculation of the class. PROFILE OF THE CLASS OF 2001

- 358 students selected from 3,443 applicants from 544 different colleges and universities
- 193 non-resident students from 40 different states and the District of Columbia
- 148 women
- 52 minority students among the 294 who identified their ethnicity
- median GPA: 3.7 on a 4.0 scale
- median LSAT: 95th percentile
- average age: 25

Although widely differing approaches to college grading often serve to render comparative statements about undergraduate records misleading, it is significant that most of the students in the Class of 2001 ranked in the upper 20 percent of their graduating classes. Many of these students also completed advanced degree work.
