PROFILE OF THE CLASS OF 2003

- 336 students selected from 3,238 applicants from 516 colleges and universities
- 210 non-resident students from 44 states, the District of Columbia, and 3 foreign countries (France, Germany and South Korea).
- 191 men, 145 women
- 53 minority students among the 276 who identified their ethnicity
- median GPA: 3.63 on a 4.0 scale
- median LSAT: 166
- average age: 24

Although widely differing approaches to college grading often serve to render comparative statements about undergraduate records misleading, it is significant that most of the students in the Class of 2003 ranked in the upper 20 percent of their graduating classes. Many of these students also completed advanced degree work.
