The Commission on Euran Rights,

Raying in mind the draft convention on the rights of the child submitted by Poland on 7 February 1978, 3'

Taking into account the report of the Secretary-General on the views, observations and suggestions on the question of the convention on the rights of the child submitted by Number States, competent specialised agencies, regional intergovernmental organizations and non-governmental organizations (E/CM.4/1324 and Corr.1 and Add.1-4),

Taking note of the report of the Working Group set up at the thirty-fifth session of the Commission to draw up the convention on the rights of the child, 2

Considering that owing to lack of time it was not possible to complete work on the draft convention on the rights of the child,

Recalling Economic and Social Council resolution 1978/18 of 5 May 1978 and General Assembly resolution 35/166 of 20 December 1970 relating to the question of the convention on the rights of the child,

Convinced that it would be desirable to adopt an international convention on the rights of the child in commexion with the International Year of the Child.

- Decides to continue at its thirty-sixth session, as a matter of priority, its
 work on a draft convention on the rights of the child with a view to completing, if
 possible, the elaboration of the said convention at that session for transmission to
 the General issembly through the Economic and Social Council.
- Requests the Economic and Social Council to bring to the notice of the Ceneral Issembly at its thirty-fourth session the present resolution and the relevant chapter of the report of the Commission on Human Rights on its thirty-fifth session.
